ERNEST MARIO SCHOOL OF PHARMACY AT RUTGERS UNIVERSITY

Ernest Mario School of Pharmacy at Rutgers University is part of Rutgers Biomedical Health Sciences (RBHS) and participates in interdisciplinary professional education and training partnerships with Rutgers School of Public Health and the Robert Wood Johnson Medical School.

This Fellowship program, in partnership with Janssen Scientific Affairs, LLC, part of the Janssen Pharmaceutical Companies of Johnson & Johnson, Real World Value & Evidence (RWV&E) group, offers a significant opportunity to individuals interested in health economics, cost and services utilization analysis, and patient-reported outcomes research. RWV&E is comprised of Market Access scientific strategists with the mission to deliver real-world evidence

mission to deliver real world evidence

to a variety of U.S. stakeholders in healthcare, including patients, providers, and payers. Composed of practical research experience, didactic courses, and seminars, the program provides training in the application of RWV&E in an industry setting, including designing and conducting outcomes research studies that examine economic, clinical, and humanistic outcomes.

The Fellow will be employed for up to two years by Rutgers University and will work onsite with researchers at Janssen Scientific Affairs, LLC RWV&E offices located in Titusville, New Jersey.

FELLOWSHIP TRAINING ACTIVITIES MAY INCLUDE:

- Contributing to trial design planning to incorporate patientreported outcomes (PROs) and health economic measures through conducting evidencebased literature reviews and PRO questionnaire evaluation
- Conducting burden of illness evaluations to better characterize patient and population unmet needs through database analysis and literature reviews
- Developing health economic models to characterize and

- communicate the budget impact and cost-effectiveness of new or existing therapeutics
- Conducting comparative effectiveness research using Real World Data
- Participating in cross-functional teams in an effort to gain a better understanding of how RWV&E can be used in the decisionmaking process associated with the development and commercialization of new pharmaceutical products

The Fellow will also have the opportunity to learn about the application of health economics and outcomes research in an academic setting at the Ernest Mario School of Pharmacy and the Rutgers School of Public Health. Didactic training includes tuition reimbursement for up to 3 three-credit graduate courses. Course selection will be determined by the Fellow in consultation with the Fellowship's primary preceptors.

ELIGIBILITY

- Advanced degree (PhD or ScD preferred) in health services research, public health, health economics, epidemiology, outcomes research, pharmacy, pharmacy administration, or a related discipline
- A background in pharmacy or medicine and experience in outcomes research, health economics, or closely related fields of research is preferred
- Candidates must have excellent written and verbal communication skills

HOW TO APPLY

Interested individuals must submit their current curriculum vitae, personal statement, three letters of reference, and official university transcripts. For candidates who have completed a graduate or professional program within the past two years, at least one letter of reference should be from a faculty member who supervised the applicant's academic progress or graduate research.

Applicants may also be asked to complete a job application through the Rutgers University online job portal.
